POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 13 JUNE 2017

The Board is pleased to announce that all the ordinary resolutions as set out in the AGM Notice were duly passed by way of poll at the AGM on 13 June 2017.

References are made to (a) the circular dated 11 April 2017 (the “**Circular**”) of Sinopec Kantons Holdings Limited (the “**Company**”) and (b) the ordinary resolutions as set out in the notice of annual general meeting (the “**AGM**”) dated 11 April 2017 (the “**AGM Notice**”) contained in the Circular. Unless otherwise defined herein or the context otherwise requires, capitalised terms and expressions used in this announcement shall bear the same meanings given to them in the Circular.

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company is pleased to announce that all ordinary resolutions as set out in the AGM Notice were duly passed by way of poll at the AGM held on 13 June 2017.

As at the date of the AGM, the number of issued shares of the Company was 2,486,160,000, which was the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no Shares entitling the holders to attend and abstain from voting in favour of the ordinary resolutions proposed at the AGM as set out in Rule 13.40 of the Listing Rules, or abstain from voting as required under the Listing Rules. No Shareholder had indicated in the Circular that he/she intended to vote against or abstain from voting on the ordinary resolutions proposed at the AGM.

The Company's share registrar in Hong Kong, Tricor Secretaries Limited of Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong, was appointed as the scrutineer at the AGM for the purpose of the vote-taking.
